I. CALL TO ORDER	Meeting began at 9:40 a.m. Ms. Evelyn Alvarez welcomed everyone in attendance and expressed gratitude for all the holiday greeting cards and wished all a Happy New Year.	
II. STATE / AREA AND APD UPDATE	 Ms. Evelyn Alvarez extended condolences to all of those affected by the Haiti disaster; thoughts and prayers are with you. Moment of silence was observed. APD has been actively involved at the State EOC by having a support representative there. There have been many transports from Haiti to South Florida for medical assistance and efforts for repatriation of the U.S. citizens that were already in Haiti. To this effort, there have been over 6600 individuals to arrive here and more than 2700 have been receiving ongoing supports. Recurring aftershocks are of concern at this time. Expectation of a mass migration is being anticipated and planning is in progress. The Governor signed an order giving temporary protective status those Haitian illegal immigrants within the State of Florida, allowing them to submit their applications for employment and federal government assistance. The State of Florida EOC is still continuing to work on the H1N1 responses in addition to Operation Haiti Relief as it relates to safety and security. 	• For more information about the Agency for Persons with Disabilities, please contact Evelyn Alvarez at (305) 349-1478.

CONTINUED STATE / AREA AND APD UPDATE	 Technology Specialist and Douglas Marans, Certified Behavior Analyst. Welcome aboard! I-budget Florida is ongoing. Stakeholder and public meetings are taking place to gather feedback and information in order to report to the Legislature on February 1, 2010. The South Florida meeting is scheduled for January 22, 2010, in Hollywood, FL from 9 a.m. to 12 p.m. at 6411 Taft St. Another stakeholders meeting will be held at the end of the month. Further directions are forthcoming as to how we will proceed with the I-budget project. An email was sent reminding you of the importance of reviewing the information pertaining to Medicaid fraud with your staff. This is critical! There is a rise in the number of fraud cases being reported. Please educate your staff on the consequences of fraud. 	
	 Ms. Carolyn Eleby announced that we were unable to meet the previous 5-year Supported Employment initiative goals and we will be making changes in this area with better collaboration with our community partners so that we will be prepared for the new 5-year goals and initiatives already in progress. Ms. Eleby thanked WSCs for their quick response to the new Delmarva quality assurance efforts requiring caseload listings in order to create a database for quality assurance. We have been working diligently with the Medicaid and EDS offices in the enrollment of individuals on the Medicaid State plan for PCA providers. Consumers who are under the age of 21 will now have to receive PCA services through state Medicaid. The waiver will no longer serve those consumers. Ms. Migdalia Diaz-Prado encouraged registration for the one-time SL refresher course. Providers please ensure that your billing invoices, vendor forms and financial profiles are completed properly. Please review and give your full attention to all signed documents. Improper attention to this matter results in late payments. 	

Corrective actions will follow to those providers who are in non-compliance.
 Mrs. Marcie Brittain reported that the Family Care Council (FCC) for Area 11 has 8 members. People are welcome to come to the meetings. Explore the website for meeting dates or contact Mrs. Brittain for more FCC information. The Person-Centered Planning training for WSC's has been postponed. The new dates are April 26-27 and April 28-29, 2010. These are two-day sessions to hold a capacity of 30 participants in each. More information will follow and Mrs. Brittain will be in contact with the WSC's.
 Ms. Sharon-Powell featured thyroid awareness and wished all good health. Thyroid disorder are more common among women and is the fastest growing cancer in America, but the most curable. The thyroid aids in the delivery of oxygen, metabolism function and disorders can contribute to weight gain or loss, fatigue, high cholesterol, depression, lack of energy and Hyperthyroidism.
Flu season continues until March. H1N1 vaccines are still available to the public and remember your cough and cold prevention etiquettes.
 Ms. Hillary Jackson announced that the CDC+ trainings are ongoing and are for interested families. There have been positive results. Late applications are still being accepted in Central Office. We have, however, been getting reports that WSC's are discouraging families from participating in the CDC+ program. There are no trainings at this time for new consultants.
 ABC must be kept updated. It is not an option. Corrective actions are being issued. ACLM1 & ACLM2 screens must be certified. This assignment was due from November 5, 2009.

Data queries, budget projections are run off of ABC data.

*	 Please check your caseload in order to update ABC. Families/consumers are not receiving copies of their support plans. Support plans are an annual exercise. Please be responsive to the families' phone calls, voice mails, and assignments from Area Office. Please contact the providers of your consumers under the age of 21, to verify if they will be enrolled in the Medicaid state plan for PCA services. Tier reviews will be done by the QSI assessors. More details will follow when the final procedures are complete. The rebasing data has a glitch. The project is on hold because the WSC billing costs were not included in the data. New data is forthcoming. As a result, some consumers may or may not need to be rebased. Please pay close attention to those consumers under of age 21 that have PCA services. Workload reduction does not apply to the WSC's who do not have consumers that are being rebased.

 Mrs. Maria Springer reported that the General Revenue (GR) is continuing to expand on our community resource guide which is available on the APD website. The third quarterly waitlist meeting was held in Monroe County. Community Resources were provided for these in
