NOTE!!! Agencies/Providers are responsible for coverage of the Rating Session as scheduled. There are no alternates.

For minimum coverage of one session monthly with 4 add rating sessions annually. Agencies with:

1-2 group homes, 1 Rater or 2 rating sessions

3-4 group homes 2 Raters or 3 rating sessions

5-6 group homes 3 Raters or 5 rating sessions
7-8 group homes 4 Raters or 6 rating sessions
9-10 group homes 5 Raters or 7 rating sessions
11-12 group homes 6 raters or 8 rating sessions
For each ADT at an agency, add one Rater.
