## **COVID-19 Vaccinations for Assisted Living Facilities**

---

In accordance with Governor DeSantis' efforts to expedite vaccinations for assisted living facility residents and staff, the Division of Emergency Management has contracted with CDR Health to vaccinate assisted living facilities that are not scheduled for their initial vaccine clinic with CVS or Walgreens on or before January 23. CDR Health will be contacting assisted living facilities to make arrangements for vaccinations.

Assisted living facilities will receive three clinic dates from CDR Health –

- Clinic 1: Initial vaccinations of staff and resident
- Clinic 2: Second dose vaccinations for those who were vaccinated at Clinic 1, and initial vaccinations for additional/new staff and residents
- Clinic 3: Second dose vaccinations for those who received initial vaccinations during Clinic 2

All second doses will be fulfilled by the provider of the first dose, so any ALF served by CVS or Walgreens will finish second doses with that same provider.

CDR Health will provide all consent forms to be used and share this information when initial contact is made to arrange an onsite clinic.

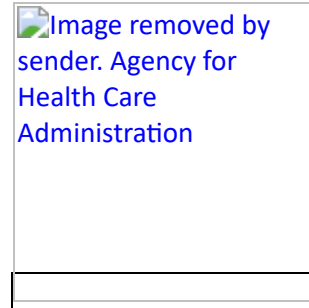
